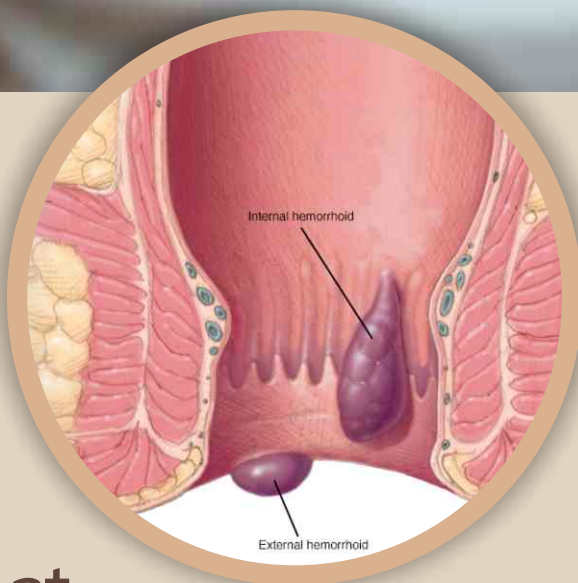

Treat Hemorrhoids with Ayurveda

Piles is a painful disease that occurs due to chronic constipation, chronic diarrhea, lifting heavy weights, pregnancy, or straining while passing a stool. When tissues and veins in the anal canal become inflamed and swollen, it leads to painful passing of stool and bleeding in the worst cases. It is of two types: Internal and External Piles. Internal piles are normally located between 2 and 4 centimeters (cm) above the opening of the external piles occur on the outside edge of the anus and are comparatively more painful.

Symptoms

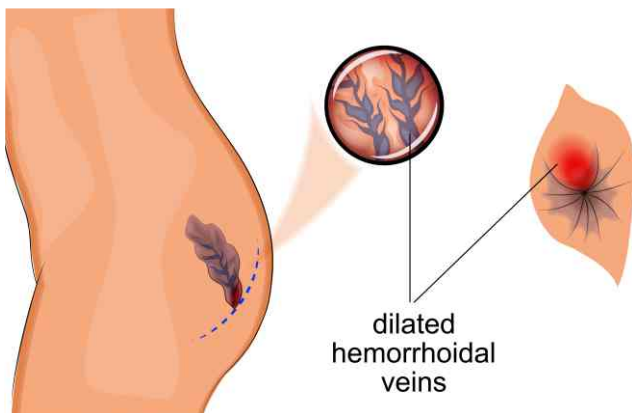
- Rectal Bleeding before or after secretion.
- Anal swelling, redness and itching
- Anal fissures and lumps
- The area around the anus is itchy, red, and sore.

Causes

Piles are caused by increased pressure in the lower rectum.

The blood vessels around the anus and in the rectum will stretch under pressure and may swell or bulge, forming piles. This may be due to:

- Chronic constipation
- Chronic diarrhea
- Lifting heavy weights
- Pregnancy
- Straining when passing a stool



The tendency to develop piles may also be inherited and increases with age.

Food Preferences:

- Avoid eating food that leads to constipation like white flour and dairy products.
- Eat fibrous vegetables and seasonal fruits like papaya, blackberry, banana, green leafy vegetables, apple, etc.
- Avoid smoking and drinking alcohol.
- Avoid spicy and fried food.

Exercise

- Regular exercise will help to reduce weight and cure constipation thereby help in curing piles.
- Yoga asanas like Kapalbhati, Bhjangasana, Dhanurasana, Paschimottanasana, Sarvangasana, etc, along with Anulom-Vilom Pranayama.

Treatment

- Mix 30ml. Aloe Sanjivani Juice, Aloe Vera Juice and 2 drops of Shri Tulsi in water and drink this mixture daily in the morning and evening on an empty stomach.
- Consume 2 tablets of Fresh Morning at night before going to bed.
- Consume 1 tablet of Piles Away in the morning and at night.
- Have Swadisht Pachan Churan after meals in the morning and at night.
- Apply Piles Away Cream at the infected area twice a day in the morning and at night.

who dared to face challenges and emerged victorious

Sandeep Singh Bhinder

Sandeep Singh Bhinder is an Indian professional field hockey player and an ex-captain of the Indian National Hockey Team. He made his international debut in January 2004 in Sultan Azlan Shah Cup in Kuala Lumpur. At the peak of his career, he had the best speed (145km/hr) in the world in drag flick. On 22 August 2006, he was travelling in Shatabdi on the way to join his team to leave for the World Cup in Germany which was about to happen two days later. In the train, he was gunshot accidentally which paralyzed him and he was on a wheelchair for two years of his life. Often people lose their spirit and become bedridden for rest of their lives but Sandeep Singh Bhinder is a man that does not quits. He didn't lose hope and with his indomitable spirit not only recovered from paralysis but also established himself again in the team.



He became captain of the Indian National Team in January 2009. Under his captaincy, the Indian team managed to win the Sultan Azlan Shah Cup in 2009 after defeating Malaysia in the finals at Ipoh. India won the title after a long wait of 13 years and he was the top goal scorer of the tournament. The India men's national Hockey team had qualified for the 2012 Summer Olympics in London after a gap of 8 years. The team had a resounding victory over France in the finals of the Olympic qualifiers by beating France 8–1. Ace drag-flicker Singh starred in the final against France by scoring five goals – including a hat-trick – all from penalty corners (19th, 26th, 38th, 49th and 51st minutes). Singh was the highest scorer of the Olympic qualifiers tournament by scoring 16 goals.

He is regarded as one of the best drag-flickers of the game. He is a legend who was on top of his game but suffered by the hands of destiny. Often we say that we could not reach our goals and fulfill our dreams because it was not in our destiny. But, he is the man

who not only made impossible to possible but set an example that our resilience can change the destiny and make us an invincible warrior. So, friends, if a paralyzed sportsman can decide to overcome his challenges and make India proud, then all we need is to stay focused and fearless to change our lives and become successful.

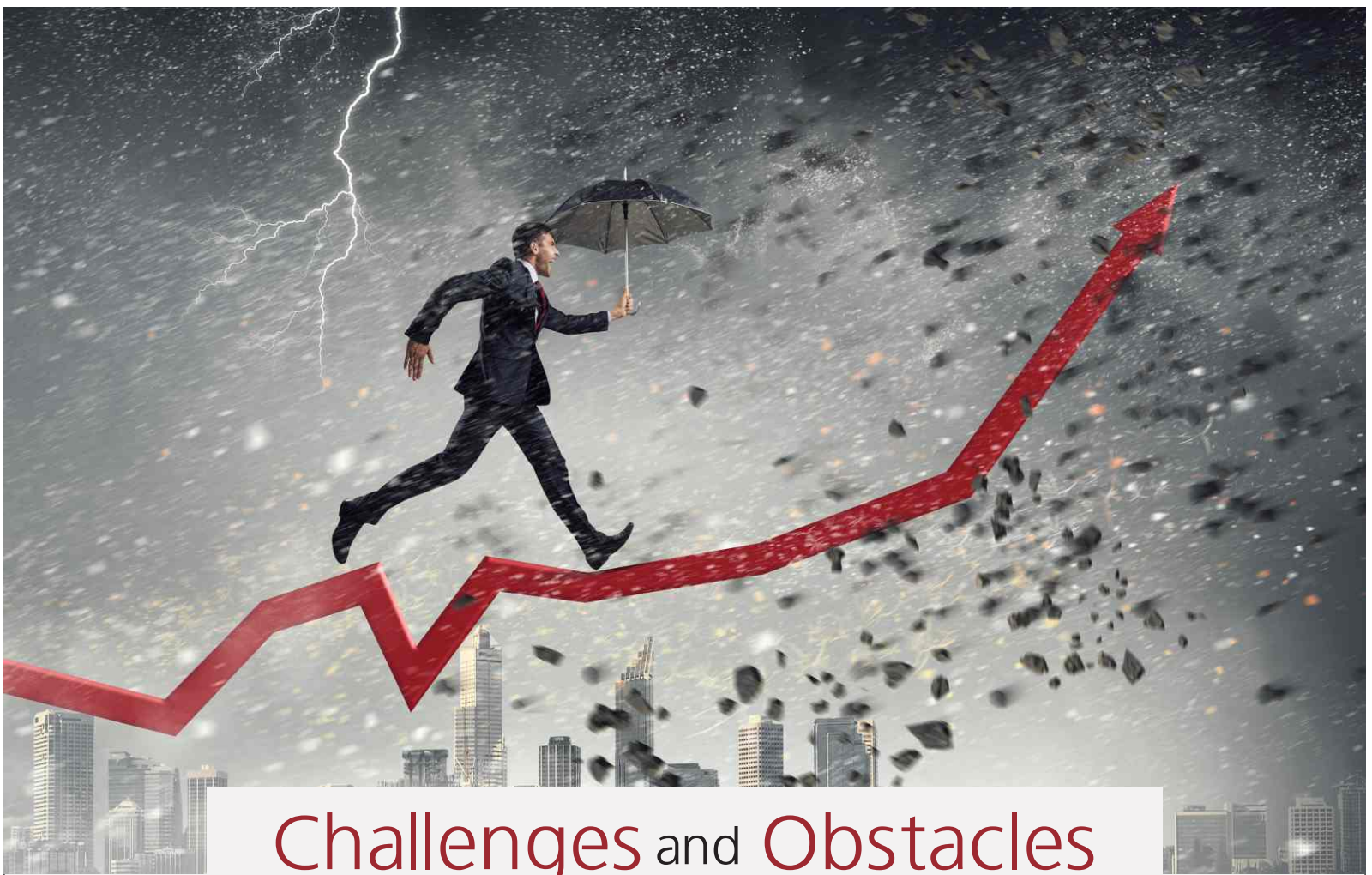

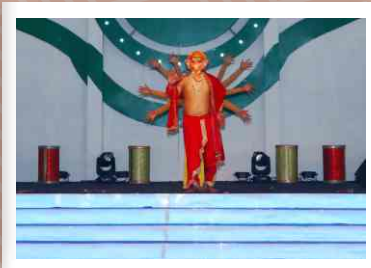
